

SNOW REMOVAL

Sidewalks not cleared of snow and ice are a public safety issue. The public must have a safe route to walk, particularly our children on their way to school. The borough's snow removal ordinance addresses this concern by requiring all property owners (owners of a private residence, business, or rental property) to keep their sidewalks clear of snow and ice by enforcing the following:

Sidewalks must be cleared of snow within 24 hours after snow stops falling. Cleared paths must be a minimum of 30 inches wide. **F**or ice, an anti-skid abrasive or ice melt product must be applied **AT NO TIME** are you permitted to shovel, plow, blow, or by any other means deposit snow into the street.

If you will be away from home and unable to clear your sidewalk within the 24 hours,

you must plan to have someone clear it for you.

Announced on WFMZ in Allentown, both TV and Radio Listed on the message board in front of borough hall Posted to the borough's Facebook page Via Ready Bucks, the Mass Notification System used by the Borough (registration instructions on page 13)

When a snow emergency is declared, ALL vehicles, including trailers, MUST be removed from the streets to allow for curb-to-curb plowing. If you do not have adequate off-street parking, you can utilize the borough parking lot at Veteran's Park until the 'snow emergency' status is canceled.

When snow is predicted, with or without a snow emergency declaration, please make every effort to remove your vehicles from the street to ensure effective snow plowing.

Checking your water distribution pipes for lead

New state and federal laws require us to inventory all water service lines in our service area. A service line is an underground pipe that carries water from the water main, in the street, into your home or building. Trumbauersville Borough Water Department owns and maintains the portion of the service line from the water main to the curb stop located at the private property boundary. The portion of the service line located on private property is the responsibility of the property owner. The Borough is in the process of verifying the material of all service lines. Major water system upgrades completed in the 1990s replaced water mains and system-owned portions of service lines throughout much of the Borough. Service line replacements (to the property boundary) completed during this work are constructed of copper and are lead-free. We need to determine the type of material the privately owned portion of your service line is made of. To do this, we will need your help.

Service lines are often copper, plastic, lead, or galvanized iron or steel. Older homes and buildings may have a lead service line. Drinking water is free from lead when it leaves our water treatment plant. However, water can absorb lead as it travels through lead pipes on its way to your faucet. Lead can cause serious health problems. If you have a lead service line,



we need to take steps to reduce your lead exposure risk. Knowing your service line material is very important for your health and safety!

Look for a survey link on the borough website www.trumbauersville.org. The survey is the quickest way to get the necessary information on your service line submitted to the borough. Thank you.



Before the Storm

- PennDOT holds statewide Web conferences with department staff, weather experts and officials from PEMA and State Police to discuss upcoming weather and discuss preparations or sharing resources as needed.
- Department crews may pretreat with salt brine, essentially a mix of water and salt, from the backs of anti-icing trucks before frozen precipitation starts to fall.
- Salt brine is NOT a silver bullet and it isn't appropriate for every storm, but when it's used it helps prevent ٠ precipitation from bonding to the road and gives the department a jump start on removing ice and snow.
- Crews generally will not pretreat with salt brine when a storm is forecast to start as rain (rain will wash the material away) or when there is enough salt residue from a previous storm.
- PennDOT monitors weather forecasts to gauge when to call crews into action. ٠
- Especially in high traffic areas, PennDOT may stage plows along major routes and interstates so they can quickly begin treating the roadway when precipitation begins.
- Some PennDOT regions use private contractors to supplement its state crews through the whole winter, while some areas supplement their crews based on storm forecasts.

During the Storm

- While snow is falling, roads will NOT be free of ice and snow.
- Why not? If snow is falling at 1 inch per hour, for example, and a truck takes three hours to return to the start of its route, 3 inches of snow has fallen.
- Whether an operator is plowing snow from a roadway depends on the depth or heaviness of snow or slush, severity of the storm and in what stage of the storm the truck is being operated.
- During a storm, plows use the same roads we all travel on. As traffic or precipitation increases, so does the time it ٠ takes for a plow to complete its route. If you're stuck in traffic, so are we.
- This means that if storms hit at rush hour, you should plan extra time for your commute.
- ٠ PennDOT provides additional service to areas near schools and other large public gathering places.

Materials

- PennDOT plow operators use technology in their trucks to monitor air temperature and road temperature so ٠ they can tailor their road treatment on the go.
- The major factors that determine what material will be used on a roadway are temperature and traffic.
- Because salt is most effective when traffic is crushing and spreading it on the road, the lower a road's traffic volume, the more PennDOT will mix salt with anti-skid or other materials.
- Salt also isn't a silver bullet it becomes less effective once temperatures dip below 23-25 degrees.

Higher Traffic Roads

- Whether salt is pre-wetted or mixed with other materials during a storm depends on temperature, precipitation type and a road's traffic volume.
- A salt/anti-skid mix can be used when road surface temperatures are below 15°F, as straight salt and salt/ chemical applications are less effective at lower temperatures.
- · On higher traffic roadways, PennDOT may also wet or pre-wet road salt with salt brine to jump start the salt's melting action. But even this tactic is most effective when the pavement temperature is 25 degrees or higher.
- Pre-wetting salt can also help keep salt on the road by reducing bouncing.

Lower Traffic Roads

- On the state's lowest-traffic roadways, PennDOT will focus its salt/anti-skid usage on areas like hills, bridges, intersections, sharp curves or freezing-prone areas. Because traffic volume is generally too low for salt alone to be effective on these roads, anti-skid will be mixed in to help with traction.
- Anti-icing is generally not performed on low-volume roadways at below 15 degrees because falling snow is generally dryer and usually blows over the roadway surface.

PennDOT Winter Storm Tactics

(ST 1-14)

WHAT IS ARSENIC AND WHY IS IT IN MY WATER?

Arsenic is a naturally occurring element found throughout the environment. Most people's exposure to arsenic, including inorganic arsenic compounds, occurs through their diet. (see attached information from the FDA at the end of this)

Inorganic arsenic is primarily used as a preservative to make wood resistant to rot and decay. Although its use for certain residential items, such as decks and picnic tables, has been phased out, Inorganic arsenic is still used in industrial applications.

The use of arsenic in agricultural or commercial pesticide applications has been restricted and is most recently limited to organic arsenic compounds in a limited number of approved uses.

Common sources of arsenic are erosion from natural deposits, runoff from orchards, and runoff from glass and electronics production waste. Sampling results from various sources indicate that increased withdrawal from a well may cause an increase in groundwater concentration of arsenic in the raw water, especially during low groundwater table/drought conditions. (https://www.epa.gov/report-environment/ground-water)

WHAT ARE WE DOING ABOUT IT?

In 2001, the EPA adopted a lower standard for arsenic in drinking water that applies to both community and non-transient non-community water systems. The new arsenic standard of 10 parts per billion (ppb) replaces the old standard of 50 ppb. (https://www.epa.gov) In 2020, the Food and Drug Administration established a similar action level of 10 ppb for apple juice. (https://www.fda.gov/news)

Raw groundwater arsenic levels in southeastern PA are variable. Trumbauersville has had values ranging from a high of 0.020 ppm to a low of 0.003 ppm, with typical values of 0.012 to 0.015 mg/L arsenic. In 2009, Trumbauersville installed arsenic removal treatment in Well 3, with remediation in Well 2 installed in 2014. To comply with PA DEP regulations, *treated* water must be at, or below, the new arsenic MCL at 0.010 ppm.

In 2023, the level of arsenic in our raw groundwater (before treatment) increased to 0.023 ppm, which resulted in updating the existing treatment system to reduce the finished water to 0.012 and 0.013 ppm, just above the current MCL. Higher groundwater arsenic concentrations were not unique to Trumbauersville; neighboring water suppliers were similarly affected.

Trumbauersville has been working with our water engineer on projects to evaluate existing treatment systems and implement immediate repairs and modifications to improve performance. The DEP is monitoring the situation and has established dates by which work is required to be completed. Modifications and repairs at Well No. 2 were completed on Friday, October 27th, well before the Thanksgiving 2023 DEP deadline. System upgrades are in the design phase for Well No. 3. A permit application for these improvements will be submitted to DEP before Christmas 2023. The Well 3 improvements will provide increased arsenic treatment capability and include the construction of an interconnection with the neighboring Milford Township water supply to provide a supplemental water source for emergency use. Construction of the Well 3 improvements is expected to be completed by the summer of 2024. Trumbauersville is working to complete these necessary actions as quickly as possible.

You can specify how to be notified, whether it be your home, mobile or business phone, e-mail, text messages and more. If you need assistance or do not have a computer, please call me at 215-536-2518 and I will help you. If you are signed up, please check that your information is up to date to ensure you to receive all information and announcements.

With the coming of Old Man Winter, it's time to check in and make sure our residents are properly prepared. Check your snow removal equipment, have spare batteries on hand, have your heater serviced and your chimney cleaned, your dried wood is stored properly, and your automobile is winterized. Ensure your medications are refilled and medical equipment properly working, having a portable generator on hand if possible. Don't forget to make sure you have plenty of food and water on hand for your animals, and ensure they are protected from the incoming weather event. Mother Nature refuses to schedule her appearance, if you want to beat her at her own game, be prepared!



If you have a fire hydrant or storm inlet in front of your home or business, please take the time to ensure they are both free from snow and debris. If you are unable to clear the inlet or remove high piles of snow around the hydrants, please ask if a neighbor or family member can assist you.

LET'S TRAVEL BACK IN TIME TO DRIVERS EDUCATION CLASS

BASIC KNOWLEDGE ANYONE WHO HAS TESTED FOR THEIR PA DRIVERS LICENSE MUST KNOW.

Q&A regarding parking concerns found in and around the borough*.

Q. Is it illegal to park facing the wrong way on residential streets? A. Except as otherwise provided, every vehicle standing or parked upon a two-way highway shall be positioned parallel to and with the right-hand wheels within 12 inches of the right-hand curb.

"Highway." The entire width between the boundary lines of every way publicly maintained when any part thereof is open to the use of the public for purposes of vehicular travel. (Title 75 §3354 Additional Parking Regulations)



Q. Drivers only have to stop for people crossing the street if the street has painted crosswalks and there are signs that say 'yield to pedestrians in crosswalk.' A. Right-of-way of pedestrians in crosswalks. (a) General rule — When traffic-control signals are not in place or not in operation, the driver of a vehicle shall yield the right-of-way to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection. (b) Exercise of care by pedestrian. No pedestrian shall suddenly leave a curb or other place of safety and walk or run into the path of a vehicle which is so close as to constitute a hazard. (Title 75 §3542. PARKING PROHIBITIONS IN SPECIFIED PLACES

General Rule—Except when necessary to avoid conflict with other traffic or to protect the safety of any person or vehicle or in compliance with law or the directions of a police officer or official traffic-control device, no person shall stop, stand, or park a vehicle:

Within 30 feet upon the approach to any flashing signal, **stop sign**, yield sign, or traffic-control signal. - At any place where official signs prohibit - In front of a public or private driveway - Within 20 feet of a crosswalk at an intersection—On a sidewalk— Within an intersection— On a crosswalk.

Failure to comply will result in a citation issued by our Code Enforcement Officer. In order to address repeat offenders. borough council may consider adding the right to tow vehicles found in violation for the same infraction 2 or more times.

- Q. Can I park in front of a fire hydrant if I leave a little room for Firemen to access the hydrant?
- A. NO. You must park at least 15 feet away from a fire hydrant.
- **Q.** If the curb in front of a fire hydrant isn't painted, it means parking is allowed.
- **A.** Whether a curb is painted or not, in the state of Pennsylvania you may not park closer than 15 feet to any fire hydrant.
- (Title 75 §3352 Prohibitions in specified places)
