Playground Tot-Lot facelift

Starting the week of April 22nd, workers will begin deconstructing the tot-lot. The black timbers around the boundary will be removed along with all of the mulch. After the mulch removal commercial grade geotextile fabric will be installed to curb weeds.

Before the new mulch is installed, all playground equipment will be inspected for safety and continued use.

Once that work is complete, the fresh, certified playground mulch will be delivered and installed. After that time, the border will be reinstalled. Kick pads will also be put in place under the swings and at the end of the slides.

Weather permitting, all work will be completed well before Community Day.

Water Meter Upgrade Project

There are still 20 water meters that need to be replaced. If you are one of those 20 remaining homes, please take the time to follow up with the plumbing contractor to schedule your appointment. We understand that finding time in your busy schedule for a plumber to come to your house may seem a minor inconvenience, but not returning phone calls has delayed the completion of this project another three months.

Please remember, **the water meter is borough property** and therefor **must be made accessible to borough employees/contractors** with advanced notice to the property owner.

Please contact Alex Buono, (the plumbing contractor hired for this project) directly at 215-833-3740 to schedule your meter replacement. The meters must be installed by April 30, 2024. The new billing software and transponders cannot be installed until all of the meters are replaced. The initial completion was targeted for the first quarter reading; with the delay we have shifted completion to the second quarter.



What's the next step?

When the meter replacement is complete, the next step is to install the transponders. The transponder unit will be installed over the 'black button' (touchpad) that is mounted on the outside of your house. The touchpad is the current path of communication to the meter for consumption readings. Unless the touchpad needs to be rewired, there will be no need for the installer to come inside the house.

Once all of the transponders are installed, the water department billing software will be installed and tested to ensure everything is for the 2nd quarter meter reads. Once the new system is operating, meter readings will be communicated from the individual transponders to the remote reader. There might be a learning curve, but once the system is fully operational the man hours spent reading meters will significantly decrease while billing and meter accuracy increases.

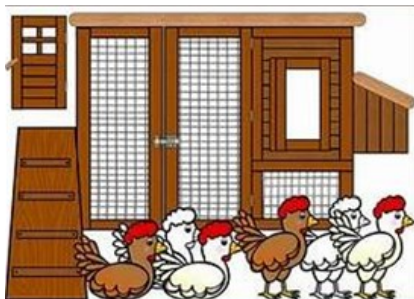

CLEAN UP TIME!

Do not blow grass clippings into the street. They end up collecting and clogging storm inlets. Residents are responsible for clearing grass clippings from their sidewalk, blowing them back into the yard, **not into the street.**

Contrary to popular belief, grass clippings do not cause thatch buildup, which can damage the grass. In fact, they can serve as a natural fertilizer, providing essential nutrients to the soil.



Community and Health Benefits of Proper Chicken Waste Disposal

Good waste disposal isn't just beneficial for the environment; it also makes life better for people living close by.

When waste isn't handled correctly, it can seep into groundwater, affecting drinking water quality. It's important to have effective treatment processes to keep our water safe.

Spring cleaning also applies to the stuff collecting in your yard. Things that you know need to go but that you don't know where to take it, or who to call to take it away for you. If you have unregistered vehicles, including recreational vehicles like boats, campers, or ATV's sitting in your yard or driveway, get rid of them now before you get a letter from the Code Enforcement Officer.



Rabbits produce a significant amount of waste!

Properly managing rabbit waste is essential for maintaining a clean and healthy environment. Rabbit waste can be disposed of in the trash. It's important to use a **biodegradable bag** to prevent the spread of harmful bacteria and parasites.

The Potential Health Hazards Of Improper Disposal

Improper disposal of rabbit waste can pose serious health risks, emphasizing the importance of responsible management. The potential hazards lie in disease transmission, as

rabbit waste can carry pathogens harmful to humans. Don't let it pile up. When you clean it up, throw it out!

Clean up leaves, refuse, and make sure all containers, boats, etc. are properly stored with covers or inverted so as not to allow standing water. Trash need lids! Get rid of old tires! Clean out rain gutters.

West Nile Virus. What is it?

West Nile Virus is a mosquito-borne disease that can cause encephalitis, a brain inflammation, and is typically spread by the bite of a mosquito. West Nile Virus was first detected in North America in 1999 and found in Pennsylvania in 2000. Prior to that, it had only been found in Africa, Eastern Europe, and West Asia.

In Pennsylvania, West Nile Virus maintains itself in nature by cycling between mosquitoes in the genus *Culex* and certain species of birds. A mosquito (the vector) bites an uninfected bird (the host), the virus amplifies within the bird, an uninfected mosquito bites the bird and is in turn infected. This cycle compounds itself through summer and fall, increasing the likelihood of someone being bitten by a diseased mosquito.



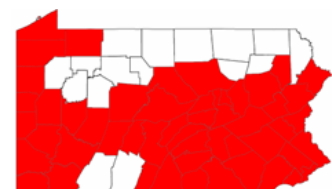
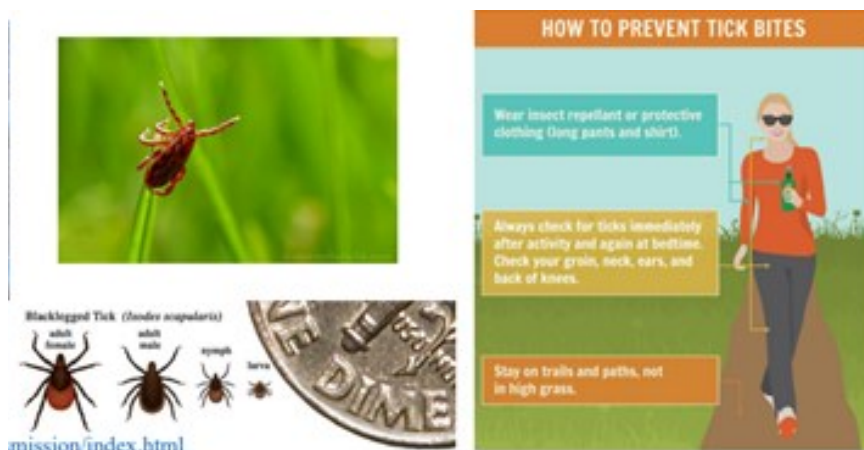
How you can help



- * Turn over wheelbarrows and don't let water stagnate in birdbaths. Both provide breeding habitats for domestic mosquitoes.
- * Aerate ornamental pools or stock them with fish. Water gardens can become major mosquito producers if they are allowed to stagnate.
- * Clean and chlorinate swimming pools not in use. Mosquitoes may even breed in the water that collects on pool covers.
- * Pay special attention to discarded tires. Stagnant water in tires is an excellent habitat for mosquitoes to thrive.
- * Eliminating tires from urban environments is critical to reducing mosquito populations associated with transmitting diseases from mosquitoes.

Tick Info: The blacklegged tick, or deer tick, is often found in wooded and grassy areas. Most humans are infected with the Lyme disease bacterium through the bites of immature ticks, called nymphs, which feed in the spring and summer months. Ticks are often found attached to humans in the groin, armpits, and scalp areas, however, they can attach any

where on the body. In most cases the tick must be attached for 36-48 hours or more before the Lyme disease bacterium can be transmitted.

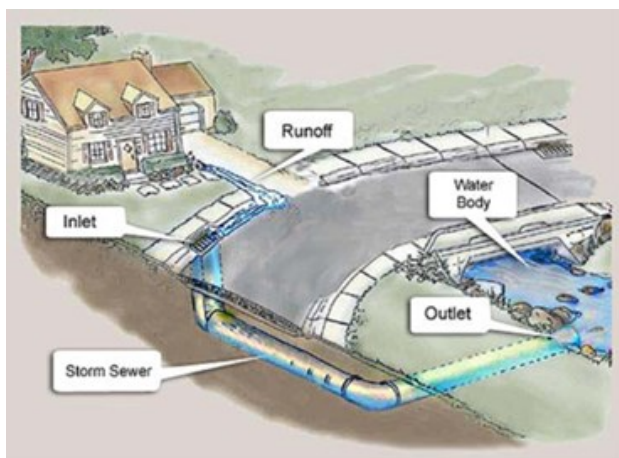
■ West Nile Virus Present West Nile Virus Not Present

There is no Poop Fairy

American dogs produce more than 10 million tons of it every year. That's 30 times the weight of the Empire State Building in dog poop! And when you consider that [the EPA has declared dog poop a pollutant](#) and even a hazard to human health—that's a problem.

Some pet owners may not understand how pet waste pollutes waterways; others may have misconceptions that lead to improper waste management, such as the idea that dog waste is an "all-natural" fertilizer and that it will "take care of itself".

It might not seem like a stormwater problem, but animal waste is one of the many seemingly small sources of pollution that can add up to big problems for water quality, and even human health. Animal waste contains two main types of pollutants that harm local waters: nutrients and pathogens. When this waste ends up in water bodies, it decomposes, releasing nutrients that cause excessive growth of algae and weeds. This makes the water murky,



green, smelly, and even unusable for swimming, boating, or fishing. The pathogens, disease causing bacteria and viruses, can also make local waters unswimmable and unfishable, and have caused severe illness in humans. As you can see, animal waste doesn't simply decompose. So, the easiest way to avoid these problems is to clean up after your pet each and every time, and dispose of the waste properly!

Picking up after your pet is easy, if you're prepared. Simply carry a plastic bag with you on every walk with your dog, and you'll have the equipment to remove your dog's waste. Then throw it in the nearest trash can, and you're done!

ALL COMPLAINTS AND CONCERNS ARE TO BE DIRECTED TO THE BOROUGH ADMINISTRATOR

The Borough Administrator is responsible for receiving complaints and finding resolutions. When submitting a complaint, either by phone message, email, US mail, or a note in the drop box, you must provide your name and address, clearly and succinctly describe the location and situation you are concerned about. The Administrator will investigate the concern and, where necessary, forward it to the appropriate department for action.

Complaints relayed to the Administrator by anyone other than the complainant, or complaints that are submitted anonymously will not be addressed.

The Resident logging the complaint remains anonymous to other parties. Their name is not included in any correspondence, discussion, or complaint investigation. While you may disagree with the answer you receive, especially when the grievance is between neighbors, you will have an unbiased outlet to voice your concerns.

Why the Administrator and not the Elected Official? A Councilperson's primary role is to legislate while the Borough Administrator is charged with managing the day to day business of the borough. She has a working knowledge of the Pa Borough Code (Title 8, PA General Assembly); is the borough's Open Records Officer and versed in the Right to Know Law and the Sunshine Act; is the Zoning Officer for the borough with knowledge of the borough's zoning ordinance and application. The Borough Administrator knows to whom information needs to be forwarded when input is required from additional parties; and receives and responds to complaints, all while ensuring anonymity where required.

PLEASE NOTE: You may not agree with the answer you are given, especially if it concerns a dispute with a neighbor, but you will find an outlet for your concerns and the most direct route to a resolution.

Neighbors

Let's make an effort to get along

Approximately 90% of the complaints received at the borough office are from people that are annoyed or aggravated by something their neighbor is doing, or in some cases, not doing and they want the borough to step in and do something about it.

I saw my neighbor doing something that just doesn't look right. Can someone from the borough go check it out?



Retaliation.

My favorite word in the dictionary. My neighbor wants to have loud parties and wreck my peace and quiet; two can play that game.

The Borough enforces ordinances, not annoyances. Residents typically want the borough to intercede on their behalf and talk to their neighbor about whatever is bothering them.

Before calling to log a complaint ask yourself this:

Is this a legitimate concern? Is the person really violating an ordinance?

Are the actions of this person bothersome because I don't approve of what they are doing, or

Is it because they are doing something that is disturbing MY peace and quiet?

REMEMBER

EVERYONE HAS THE INALIENABLE RIGHT TO ENJOY THEIR PROPERTY IN WHATEVER MANNER THEY CHOOSE WITHIN THE CONFINES OF FEDERAL, STATE, AND LOCAL LAW.

But,

IT IS IMPERATIVE THAT YOUR ENJOYMENT DOES NOT TAKE AWAY FROM YOUR NEIGHBOR'S ENJOYMENT OF THEIR PROPERTY.

If you have a legitimate concern, your first step should be a discussion with your neighbor to try and find common ground. If they are violating an ordinance, call the borough office and we will initiate an investigation. Finally, remember this, no matter what you are told, or what you hear,

Your elected officials and the borough's employees have

ZERO AUTHORITY

to mediate or Interfere in a civil dispute between neighbors in any way, for any reason.

SERVICE LINE INVENTORY UPDATE

THANK YOU to everyone that submitted their service line information. The water engineer reviewed the data and mapped the responses. We were very happy to see that almost 50% of properties have submitted their information so far.

For those who haven't returned your survey, please take the time to step into your basement and take a look at your service line. If you don't know where your line enters your house, check the basement wall facing the street. If you are unsure about the pipe material, or have any other questions, please contact the borough office and we will make arrangements to have the plumber inspect your line (at no charge to the resident).

Please remember that we are mandated by the EPA to obtain, and submit this data. It is vital that the remainder of households obtain the necessary information, and along with a picture, submit it to the borough office no later than June 1st. Once the data is received it will be turned over to the water engineer who will record and submit the information to the EPA.

WATER SERVICE LINE CUSTOMER SURVEY

On June 28, 2023, the EPA released the Small Entity Compliance Guide to support water systems, particularly small water systems, in complying with the Lead and Copper Rule Revision (LCRR) initial inventory requirements. The LCRR requires water systems to prepare and maintain an inventory of service line materials. Initial inventories are required to be submitted to state primary agencies by October 16, 2024.

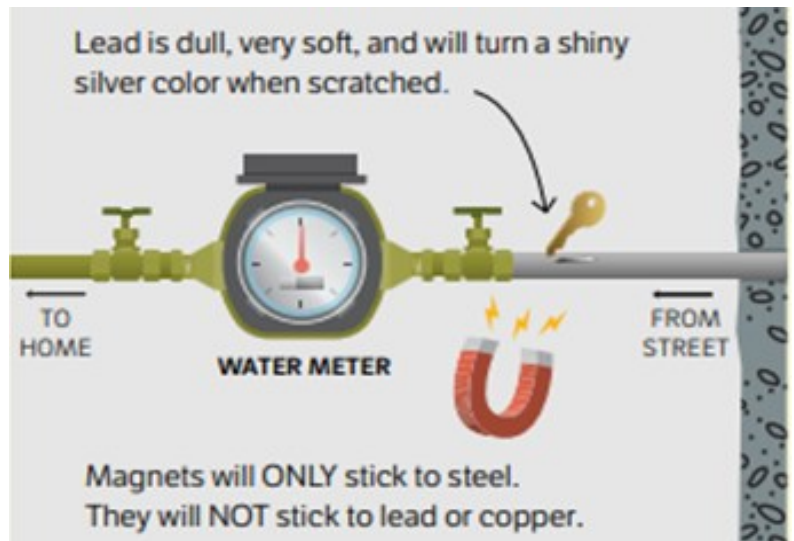

E-CYCLING

Televisions, along with computers and some other electronics (covered devices), can no longer be disposed of with municipal waste under the Covered Devices Recycling Act of 2010. Many of these

electronics contain mercury, lead, arsenic, chromium and other potentially hazardous substances. In addition to keeping these toxic substances from contaminating groundwater when landfilled, it is less expensive to recycle than to mine rare earth minerals used in the manufacturing.

Listed are several locations to drop off your television, and companies that will come to pick up your television for recycling. Some retailers offer a haul-away service with a purchase of a replacement tv.

Alternatives for the Proper Disposal of Appliances that Contain Freon

(air conditioners, refrigerators, freezers, and dehumidifiers)



The Clean Air Act of 1990 requires recapture, recycling and safe disposal of chlorofluorocarbons (CFCs) and hydro chlorofluorocarbons (HCFCs) used in air conditioners, refrigerators, and freezers as coolant. Under the Act, no one may accept an item containing CFCs and HCFCs for recycling or disposal unless the Freon contained within it is properly removed and the owner/hauler/appliance company can show proof of proper removal. It is also unlawful for any person to knowingly release or vent CFCs or HCFCs into the air. The Environmental Protection Agency (EPA) requires certification for all technicians removing Freon as of November 14, 1994.
