 - o ACTION: Motion by Councilwoman Goodin, seconded by Councilman Spor, to recognize the above-listed individuals as duly appointed Trumbauersville Fire Company Fire Police for 2025. Vote: All in favor; motion carries.
- Resolution 2025-01: Act 108 (Workman Comp. for Volunteer Fire Fighters)
 - o ACTION: Motion by Councilwoman Goodin, seconded by Councilman Spor, authorizing the adoption of Resolution 2025-01. Vote: All in favor; motion carries.
- Tree work estimates: remove two dead trees and one diseased tree; chip brush to forest underfloor and remove larger tree trunks unsuitable for firewood.
 - o Ovata Tree Services - \$4700
 - o Savage Tree Services: \$4800
 - o Doug's Landscaping - \$2650 (does not include removal of the diseased tree from the site, only cutting it down)
 - ACTION: Motion by Councilwoman Spor, seconded by Councilman Spor, awarding the project to Ovata Tree Services for \$4700. Vote: All in favor; motion carries.
- 2025 Community Day Fireworks
 - o Celebration Fireworks: \$8500 for the same show as June 2024, \$9500 for an enhanced show.
 - o Schaeffer Fireworks: \$7500 for a show equivalent to the June 2024 fireworks display.
 - ACTION: Motion by Councilman George, seconded by Councilwoman Goodin, to award Schaeffer Fireworks the contract to include the following stipulations:
 - All fireworks must use electronic igniters (no hand firing permitted)
 - Additional fireworks provided by Gary Parzych must be listed in the contract and match those listed on the Fire Marshall's permit and inspection certificate.
 - Vote: all in favor, motion carried.
- Speed monitoring radar sign for N. Main St.
 - o Motion by Councilwoman Hahn, seconded by Councilman Spor, authorizing the purchase of a speed monitoring sign for N. Main Street, supplied by All Traffic Solutions for \$5459 to be paid from the Highway Aid Fund. Vote: All in favor; motion carries.

- Traffic calming measures for East Broad Street:
 - o Motion by Councilwoman Hahn, seconded by Councilwoman Spor, to move forward with obtaining permits and approvals from PennDOT to install three (3) speed tables at the recommended intervals on East Broad St. between the light at Tollgate Rd. and the stop sign at Allentown Rd. Vote: All in favor; motion carried.
